LIMITED WARRANTY

Lynx System Developers, Inc. ("Lynx") warrants the Products listed in Attachment A against defects in material or workmanship as follows:

1. **LABOR:** For a period of one (1) year from the date of purchase, if these Products are determined to be defective, Lynx will repair or replace the Products, at its option, at no charge. After the Warranty Period, you must pay for all labor charges.
2. **PARTS:** In addition, Lynx will supply, at no charge, new or rebuilt replacements in exchange for defective parts for a period of one (1) year. After one (1) year from the date of purchase, labor for removal and installation is available from Lynx at your expense.

To obtain warranty service, you must deliver the Products freight prepaid, in either their original packaging or packaging affording an equal degree of protection, to Lynx.

This warranty does not cover customer instruction, installation, or set up adjustments. Lynx does not warrant any hardware components that are not manufactured by Lynx, including without limitation, computer systems and peripherals, camera mountings, lenses, cables, power supplies and carrying cases. Lynx will transfer or assign to you other manufacturer's warranties that are transferable or assignable, if any.

This warranty does not cover cosmetic damage or damage due to acts of God, accident, misuse, abuse, negligence, or modification of, or to any parts of the Products. This warranty does not cover damage due to improper operation or maintenance, connection to improper voltage supply, improper connection among components, or attempted repair by anyone other than Lynx. This warranty does not cover Products sold AS IS or WITH ALL FAULTS, or consumables (such as fuses).

Proof of purchase in the form of a bill of sale or receipted invoice which is evidence that the unit is within the Warranty Period must be presented to obtain warranty service.

This warranty is invalid if the factory-applied serial number has been altered or removed from the Products.

REPAIR OR REPLACEMENT AS PROVIDED UNDER THIS WARRANTY IS THE EXCLUSIVE REMEDY OF THE CONSUMER. LYNX SHALL NOT BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES OR BREACH OF ANY EXPRESS OR IMPLIED WARRANTY ON THESE PRODUCTS OR ANY PRODUCTS SOLD BY LYNX, EXCEPT TO THE EXTENT PROHIBITED BY APPLICABLE LAW, LYNX DISCLAIMS ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE ON THESE PRODUCTS OR ANY PRODUCTS SOLD BY LYNX.

Some states do not allow the exclusion or limitation of incidental or consequential damages, or allow the exclusion of implied warranties, so the above exclusions or limitations may not apply to you. This warranty gives you specific legal rights, and you may have other rights which vary from state to state.
